

END-USER LICENSE AGREEMENT FOR TitaniumGP IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM
INSTALL: AdvTrex End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and AdvTrex. for the AdvTrex TitaniumGP(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("TITANIUMGP"). By installing, copying, or otherwise using the TITANIUMGP, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and AdvTrex, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the TITANIUMGP.

The TITANIUMGP is protected by (or in process) copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The TITANIUMGP is licensed, not sold.

1. GRANT OF LICENSE.

The TITANIUMGP is licensed as follows:

(a) Installation and Use.

AdvTrex grants you the right to install and use copies of the TITANIUMGP on your client computers running a validly licensed copy of Microsoft Dynamics™ GP 2010, GP 2013, GP 2015 or GP2016 for which the TITANIUMGP was designed for.

(b) Backup Copies.

You may also make copies of the TITANIUMGP as may be necessary for backup and archival purposes.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the TITANIUMGP.

(b) Distribution.

You may not distribute registered copies of the TITANIUMGP to third parties. Evaluation versions available for download from AdvTrex's websites may be freely distributed.
